Community Solutions Inc.'s (CSI) Alternative in the Community (AIC) Programs are community-based alternatives to incarceration that provide multifaceted intervention services for offenders awaiting trial, or who are on probation or parole. The program uses Motivational Interviewing techniques and a curricula-driven, evidence-based model designed to assess the needs of each client to reduce individual risk factors. Participants work closely with case managers, intervention and employment specialists to develop individual goals and make positive changes in their lives.

A study of AIC programs by the Vera Institute of Justice (2003) showed that successful graduates of an AIC program were less likely to be convicted of a new offense. Community Solutions Inc. consistently boasts an 80 percent successful discharge rate or higher among AIC clients.

Cut Costs

Effective alternative to incarceration policies save money and make better use of limited resources by establishing a more coordinated and comprehensive continuum of care and supervision. Even small reductions in recidivism rates will generate substantial cost-savings by avoiding more costly incarceration. AIC programs operate at a fraction of the cost of a prison bed.
